BE IT FURTHER RESOLVED, that Article Five of the Articles of Incorporation of the corporation be and hereby is amended to read as follows:

"The corporation shall have a self-perpetuating Board of Directors, in which Board there shall be vested all of the power and authority to supervise, control, direct and manage the property, affairs and activities of the corporation except as otherwise provided in these Articles of Incorporation. The first Board of Directors shall consist of three (3) persons. Thereafter, the number of Directors shall be fixed by, or in the manner provided in, the Bylaws of the corporation.

first Board of Directors "The shall be vested with the power authority to adopt the initial Bylaws and to supervise, control, direct and manage the property, affairs and activities of the corporation, and who shall hold office until their successors are duly elected and have commenced their terms of office, all as provided in the Bylaws. The rights, powers, and privileges of the directors shall be fixed in the Bylaws. Bylaws of the corporation may, from time, be altered, amended, time to

suspended or repealed, or new Bylaws may be adopted, by resolution adopted by a majority of the full Board of Directors at a meeting thereof, so long as not inconsistent with the provisions of these Articles.


